These Awards recognize members for their contributions to the Highway Engineering profession within our Delaware Valley region. ALL AWARDS WILL BE PRESENTED AT OUR APRIL DINNER MEETING. It is encouraged and preferred candidates are able to be present at our April meeting. RULES:

- Nominations must be received as a PDF electronically by 5:00 PM on Friday, January 26, 2024.
 They must be emailed to the current ASHE-DelVal Section Nominating Committee Chair, Amber Midgley (Amber.Midgley@aecom.com), by that date and time.
- A candidate must be a member of the ASHE-DelVal Section.
- Individuals may be nominated for awards by a member in any grade of membership.
- Individuals may receive only one award in a single year.
- Award recipients must be approved by the Section's Board of Directors.
- All awards are presented only in years in which, in the judgement of the Selection Committee or the Board, there is at least one suitable candidate.
- The Selection Committee will be required to nominate an alternate for Board consideration for each Award.
- The Selection Committee will also recommend to the Board whether the recipient should be nominated for applicable National or Regional awards by the Section.

SECTION MEMBER OF THE YEAR AWARDS

ASHE-Delaware Valley Section Member of the Year

- The Section's highest award is presented to an individual who is judged to have contributed significantly and substantially to the highway engineering profession.
- Membership criteria Current Member, Honorary, or Life.
- Must be a current member and has been a member of the Delaware Valley Section for a minimum of five (5) years.
- The recipient can also be considered for other recognitions in the region, such as those awarded by ASCE, PSPE, or the Engineers' Club of Philadelphia.
- Supporting information to be included for nominations listed on page 4.

ASHE-Delaware Valley Section Young Member of the Year

- This award is presented to a young member in the highway engineering profession.
- Candidate must be 35 years old or younger as of December 31, 2023 to be eligible for this award.
- Membership criteria Current Member
- Must be a current member and have been a member of the Delaware Valley Section for a minimum of two (2) years.
- The recipient can also be considered for other recognitions in the region, such as those awarded by ASCE, PSPE, or the Engineers' Club of Philadelphia.
- Supporting information to be included for nominations listed on page 4.

Supporting information shall total no more than three (3) pages and shall be submitted with the Award Nomination Form as a single PDF totaling no more than four (4) pages. The PDF will contain:

- Fully Completed Award Nomination Form
- Narrative (1 page maximum)
- Supporting Information (2 additional pages maximum)
